THE LORD'S PLACE OPERATED TWO SOCIAL ENTERPRISE BUSINESSES IN FISCAL YEAR 2020-2021, THE LORD'S PLACE THRIFT STORE AND THE CAFE JOSHUA CATERING COMPANY. 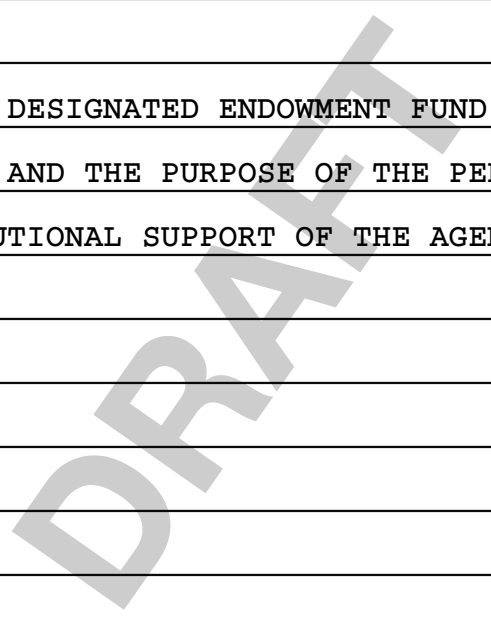
